Using Your Store 'n' Go Drive

1. Connect the drive to a PC via the USB connector to transfer files
 - i. The driver will be installed automatically
 - ii. Once the driver is installed you can transfer files in the same way as a standard USB drive (drag & drop)

2. Connect the drive to an iOS device via the Lightning connector
- When connecting the drive for the first time, a pop-up message will prompt you to download the free App "Store 'n' Go" (Figure 1)
 - Once installed, you will receive a message that prompts you to allow the App to launch whenever you plug in the drive



- Press "Allow" to launch the App



- Use the camera function to save photos and video directly to the Store'n'Go

2. You can also listen to music and watch movies stored on the drive directly with through the "Store 'n' Go" app; simply select the file to play
3. Backup your photos and videos from your iOS device to the Store'n'Go
4. The "Store 'n' Go" App allows you to easily manage the files on your drive and the iOS devices, including creating, copying, moving, deleting and renaming files etc



This product supports FAT32 format. Please format in FAT32 if reformatting is required.

1. Do not remove the drive from your PC or iOS device whilst transferring data or accessing files. Ensure you close any running programs or files prior to removing this drive.
2. To remove the drive from a PC, always click the "Safely Remove Hardware" icon on the PC taskbar, and select the drive from the pop-up menu.
